

### **About the Competition**

1. The promoter of this competition is Kidney Research UK, Kidney Care, Kidney Wales, Polycystic Kidney Disease, Renal Association, British Renal Society and National Kidney Federation, otherwise known as Kidney Charities Together for World Kidney Day UK (“KCT”).
2. By entering the competition, you agree to the below terms and conditions, to be bound by the
3. decisions of KCT and to receive social media and/or email notifications from KCT in relation to the competition.

### **Entering the competition**

4. Enter via social media – Twitter, Facebook or Instagram.
5. This competition is open to UK mainland residents (England, Scotland, Wales and Northern Ireland only aged 16 or over, excluding employees of the KCT charities and organisations and anyone else professionally connected with this competition.

Twitter – post a photo with the yellow kidney to your own Twitter profile, tag @kidneydayuk, follow @kidneydayuk and use the hashtag #KidneysMatter in your post;  
Instagram – post a photo with the yellow kidney to your own Instagram profile, tag @worldkidneydayuk, follow @worldkidneydayuk and use the hashtag #KidneysMatter in you post.
7. Your Twitter or Instagram profile needs to be public to allow us to see your post.
8. KCT will not reimburse any costs or expenses arising from the production and submission of the photo.
